#### **TERMS AND CONDITIONS**

You will be billed for 100% of your order plus your Room Rental Fee, a 7.75% state tax fee, 20% Gratuity and a standard 4% Surcharge. In effort to uphold the quality of food, service, and hospitality Mavericks is known for, the 4% surcharge is added to all guest checks to cover increasing costs, minimum wage, and employee benefits. If a Minimum Spend has been set, it must be met pre-tax, surcharge and gratuity. Remaining or additional charges must be settled the night of the event. This is an estimate - tax calculation on the POS may vary slightly.

If the minimum has not been met, it is understood that the remainder of the minimum will be rang in as an event cost. Mavericks Beach Club does not allow, gift cards to be bought to hit the minimum. Prices listed on this contract are based on information provided. Changes in total price may occur do to additional requests. Guest count and menu selections can be adjusted up to one week before the contracted event. The number of guests on this event order will be considered a guarantee for what you will be charged, even if attendance falls below the guarantee.

The client will be charged for the number of guests served, or the number of guaranteed guests, whichever is greater. It is understood that drink tickets are rang in upon consumption at the bar level price and can be redeemed for products agreed upon by the above signee (including non-alcoholic beverages).

A Credit Card is required for booking the space, and nothing will be charged until day-of. Cancellation within one week of the scheduled event will be subject to a \$500 cancellation fee. Happy hour pricing is not applicable during contracted events. House policies apply to all guests.

A Valid ID must be presented at the front door by all guests (excluding children under the age of 18) and are as follows: Valid US Drivers License, Valid CA ID Card, Valid Passport, Valid US Passport Card.

Due to our entertainment license, no persons under the age of 21 are allowed in the establishment without a parent or guardian. We reserve the right to refuse service or entrance to any guests.

No confetti or confetti/streamer poppers will be allowed during the event.

No outside bottles of alcohol are permitted on the premise during the event at all.
